## MISSION STATEMENT

Faith Christian School is a Protestant evangelical school commissioned to provide high quality and affordable education which ministers to the whole child—body, mind, and spirit. This educational experience based on a Christ-centered curriculum and rooted in Scripture, is designed to reinforce the values and morals taught in the Christian home and church. Certified Christian teachers demonstrate God's love to students while encouraging excellence and touching hearts, both for this life and for eternity.

Faith Christian School policy requires that at least one parent acknowledge Jesus Christ as personal Lord and Savior. In our community, what it means to be a born-again Christian is still unclear in the minds of some. For some it means not being a Buddhist or Muslim; for others it means being a church member or attendee. For still others, being a Christian is associated with good works or other acts of obedience. While these things may, on occasion, be indicators of genuine Christian faith, they do not get to the heart of the matter. Faith Christian School policy requires that at least one parent acknowledge Jesus Christ as Lord and Savior and bear witness to having submitted to Him individually as an act of faith.

We interpret that acknowledgement to be:

The agreement with God that they are lost and separate from God by sin and that the consequences of this sin will be an eternity of separation from God in hell.

Further, We/I understand that the Statement of Faith is the foundation of Faith Christian School's Biblical teaching and that my child(ren) will be taught accordingly on the name and reputation of the school.

We/I understand that the school reserves the right to discipline or expel any student who does not cooperate with the educational process and school policies, on or off campus. The school does not tolerate conduct that violates Biblical principles, dishonors God, or casts a poor reflection on the name and reputation of the school.

We/I understand that when a student is withdrawn or expelled, the current month's charges are due and payable, and our child(ren)'s academic records will not be released until and outstanding balances are paid in full. We/I also understand that assessments will be made if our/my child(ren) are/is responsible for damage to any school property.
